



# Guideline and Procedure to avail Reimbursement for filing IP (Patent)

## I. Guidelines for availing Reimbursement for IP (Patent) filing by Startups

#### **4** Startups eligible for reimbursement

- a) To avail the incentive, the startups should have been recognized by the Uttarakhand Startup Council AND
- b) The startup should have been incorporated in Uttarakhand and should operate from Uttarakhand or employs at least 50 percent of its total qualified workforce from Uttarakhand, which shall not include contract employees AND
- c) The patent shall be in the name of the recognized startup or shall be in the name of any of its founder or cofounder either individually or jointly AND
- d) The startups should have conducted the patentability report to determine the patentability of the product or process AND
- e) The startup should have applied/filed patent and should have paid the fees for prior art search reports, attorney fees for drafting and filing of patent, government filing fees, maintenance fees to the patent office, fees paid for international filing AND
- f) The startup should have a commitment to work on commercialization of patented product or process AND
- g) The startup should not have received incentives/reimbursement on the same patent by any other state government or central government or from any other national or international bodies

### II. Procedure for availing Reimbursement for filing IP

#### **4** Application Process

The startups who are eligible can apply for the Reimbursement of IP Filing through Startup Uttarakhand Portal by visiting at <a href="https://startuputtarakhand.com/">https://startuputtarakhand.com/</a>

The process has a mix of online and offline process which include:

• The recognized startup should login on the portal using the user id and password

- The startup shall be required to furnish the following documents online
  - The abstract of the patent filed or the draft of the patent
  - The application filing receipt for the filing of the patent with patent office
  - Copy of filing receipt for Government Filing fees available from Patent office
  - Copy of invoices and receipts from patent attorney or legal consultant for the search report, drafting and filing of the patent
  - Detailed statement of expenses incurred towards the Patent Registration
  - Certificate of the Grant of the Patent from Patent Office, if applicable
  - The startup shall furnish Self-declaration to work on the commercialization of the Patent
  - The startup shall furnish Self-declaration that it has not received incentives/reimbursement on the same patent by any other state government or central government or from any other national or international bodies
- Upon submission, the application shall be forwarded to the Nodal Agency for examination
- The Nodal Agency shall forward the application with their comments/recommendations to Task Force for decision
- During the whole process, the startups can track the status of their application by logging into their account
